Agenda

The meeting was called to order at 7:00 p.m. by Board President Dennis Bergsbaken. All Board members were in attendance with the exception of Greg Borowski and Julie Felhofer. Also in attendance were administration, staff, and members of the public.

A motion by Nate Burton was seconded by Dale Bergsbaken for approval to deviate from the Order of the Items on the Agenda, moving item 8a (Potential Referendum Planning/Discussion: Somerville) to the beginning of the agenda. The motion carried 5-0.

In Discussion, Somerville presented to the Board future building/improvement ideas, potential current costs, timelines, and various other points of reference, and answered questions as they came up.

A motion by Dale Bergsbaken was seconded by Nate Burton for approval of minutes of the July 7th, 2025, Regular Board Meeting. The motion carried 5-0.

A motion by Dave Bohm was seconded by Dale Bergsbaken for Voucher approval of checks numbered 113848 through 113889 for the period of 7/3/25 through 7/15/25 in the amount of \$129,402.03 and an ACH payment of \$181,042.19. The motion carried 5-0.

A motion by Dale Bergsbaken was seconded by Nina Rouse for the Before and After School Parent Handbook Approval as presented. The motion carried 5-0.

A motion by Dave Bohm was seconded by Dale Bergsbaken for the 3K Parent and Staff Handbook Approval as presented. The motion carried 5-0.

A motion by Dave Bohm was seconded by Dale Bergsbaken for the Elementary Handbook Approval/Standards Based Grading in Grades 3 and 4 as presented. The motion carried 5-0.

A motion by Dave Bohm was seconded by Dale Bergsbaken for the Middle School Handbook Approval/Grading Scale Approval as presented. The motion carried 5-0.

A motion by Dave Bohm was seconded by Nina Rouse for the High School Handbook Approval/Grading Scale Approval as presented. The motion carried 5-0.

In Discussion, Joe Dawidziak discussed the potential of going public with Athletic Complex Messaging once a revised version of the messaging was completed and guidance was given in that direction.

In the District Administrator's Report, Joe Dawidziak discussed the future potential of adding sections in 3K and 2nd grade later in the Summer, the apartments currently under construction in Bonduel, the upcoming inservice, and a Wellness Committee update.

In the MS/HS Principal's Report, Mrs. Dobratz discussed settling in in her transition, the recent end of Summer School Bingo event, the impact on students participating in the recent Ag Camp with Ms. McClone, participation in recent Professional Development Committee Meetings while noting how impressed she was with staff participation and the process, the recent success of the Lunch in the Park event, and an recent email she received noting how impressive it is that Bonduel has only had two Band instructors in the last 60 years.

In the Elementary Principal's Report, Mrs. Groeneveld discussed the success of the recent Lunch in the Park event, the great job of the custodial/maintenance crew in getting the buildings ready for students and staff this Fall, recent staff and parent communications, and upcoming training for all staff.

A motion by Nate Burton was seconded by Dale Bergsbaken to adjourn to closed session as authorized under Wisconsin Statute 19.85(1)(c) for the purposes of considering employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility. The motion carried 5-0.

A motion by Nate Burton was seconded by Dave Bohm to reconvene to open session. The motion carried 5-0.

A motion by Nate Burton was seconded by Nina Rouse to approve all staff raises as presented. The motion carried 5-0.
