Minutes

The meeting was called to order by Board President Dennis Bergsbaken at 7:00 p.m. All Board members were in attendance. Also in attendance were administration and staff.

A motion by Julie Felhofer was seconded by Dale Bergsbaken for the approval of Minutes of the August 21st, 2023, Regular Meeting. The motion carried 7-0.

A motion by Julie Felhofer was seconded by Dale Bergsbaken for approval of Minutes of the August 15th, 2022, Annual Meeting. The motion carried 7-0.

A motion by Greg Borowski was seconded by Nina Rouse to approve the staff retirement as presented. The motion carried 7-0. Dennis Bergsbaken, on behalf of the Board, thanked the employee for her years of service.

A motion by Dale Bergsbaken was seconded by Dave Bohm to approve the new hires as presented. The motion carried 7-0.

A motion by Dave Bohm was seconded by Dale Bergsbaken for the approval of Event Worker Compensation as presented. The motion carried 7-0.

In discussion, administrator Joe Dawidziak updated the Board on increasing enrollment numbers, the possibility of a Joint School/Municipality Meeting, and intentions for the upcoming Radio Contract. Board member Dave Bohm expressed his disagreement and requested that taxpayers be aware of the cost of the \$7,000.00 radio contract.

In the Food Service Supervisor's Report, Betsy Stanke discussed the first day of school counts and concerns regarding 5th grade lunch that had been addressed, staffing, and the smooth transition with staffing and the beginning of a new school year.

In the Maintenance Supervisor's Report, Butch Froemming discussed the start of school routine, staffing, cleaning schedules, upcoming district events, air conditioning at the Elementary, and an upcoming vacation.

In the District Administrator's Report, Joe Dawidziak discussed Inservice, new sidewalks, a stop sign that had been run over at an event, parking, the first day of school, a donation to the district, and fan behavior at events.

In the Elementary Principal's Report, Mr. Grayvold discussed recess, lunch, staffing, before and after school care providing stability and longevity for the district, the recent Open House event, and pick up and drop off at the Elementary.
