### Regular Board Meeting

### Minutes

The meeting was called to order by Board Vice President Dale Bergsbaken at 7:00 p.m. All Board members were in attendance, with the exception of Dennis Bergsbaken, who arrived at 7:15 p.m. and took over the meeting at that time. Also in attendance were administration, staff, and members of the public.

A motion by Nate Burton was seconded by Dave Bohm for approval to deviate from the Order of the Items on the Agenda, moving discussion item 8a (School District of Bonduel Tax Bill Explained) to the beginning of the agenda. The motion carried 6-0.

In discussion, administrator Joe Dawidziak presented a document related to tax bills and answered questions and took feedback regarding the document from all parties in attendance.

A motion by Nate Burton was seconded by Dale Bergsbaken for approval of Minutes of the December 1st, 2025, Regular Meeting, the December 11<sup>th</sup>, 2025, Special Meeting at 5:30 p.m., the December 11<sup>th</sup>, 2025, Special Meeting at 6:00 p.m., and the December 11<sup>th</sup>, 2025, Special Meeting at 7:00 p.m. The motion carried 6-0 with Greg Borowski abstaining.

A motion by Dave Bohm was seconded by Dale Bergsbaken for Voucher approval of checks numbered 114420 through 114499 for the period of 11/15/25 through 12/10/25 in the amount of \$96,010.85 and an ACH payment of \$388.07. The motion carried 7-0.

A motion by Dave Bohm was seconded by Dale Bergsbaken for Co-curricular voucher approval of checks numbered 32321 through 32323 for the period of 11/15/25 through 12/10/25 in the amount of \$535.24. The motion carried 7-0.

A motion by Greg Borowski was seconded by Julie Felhofer to approve the hire as presented. The motion carried 7-0.

A motion by Julie Felhofer was seconded by Nina Rouse to table the Architect Hire. The motion carried 7-0.

In discussion, Joe Dawidziak presented a revised version of a potential referendum survey looking for clarification and feedback for the next revision. There was also discussion regarding a potential 2026-2027 District Calendar version.

In the District Administrator's Report, Joe Dawidziak discussed the rescheduling of the Senior Breakfast to take place Wednesday, December 17<sup>th</sup>, and wished those in attendance happy holidays.

A motion by Nate Burton was seconded by Dave Bohm to adjourn to closed session as authorized under Wisconsin Statute 19.85(1)(c)(e) for the purposes of considering or discussing issues pertaining to compensation of certified, noncertified and administrative staff. The motion carried 7-0.

A motion by Nate Burton was seconded by Dale Bergsbaken to adjourn to open session. The motion carried 7-0.
