# 1:1 Student/Parent Agreement

## Care and Handling

*Once you are issued a device, you are responsible for keeping it secure and handling it with care.*

### Security, Storage, and Transport

- Keep the device powered off and in its' protective carrying case when not in use.
- Do not hold, lift, or suspend the devices in the air solely by the screen display or with the screen open.
- Transport the device within the protective carrying case both within the school and outside of the school.
- Handle the device with caution, even when in the protective carrying case. Do not throw, slide, drop, toss etc. a device, regardless of whether it's in its' carrying case or not.
- Use care when transporting your device in a backpack. Do not have books applying pressure to top of device, and be careful not to drop or toss the backpack as this can cause damage.
- Do not leave your device in a place where it could be easily seen and stolen i.e.: unlocked /unattended parked vehicles, including school busses.
- Do not store your device in a location subject to extreme hot or cold temperatures, large amounts of dust, pet hair, and /or moisture.
- Keep your device out of reach of family pets, younger siblings, or anyone else capable of careless handling of the property.

### Basic Care and Handling

- **You are expected to begin each school day with a fully charged battery.**
- Make sure your device is never exposed to liquids or other foreign substances, including drinks, paint, ink, glue, cleaners, polishes, or any type of health/beauty aid (lotion, nail polish, cologne, perfume, soap, shampoo, etc.)
- Use your device with clean hands – wash hands often.
- Make sure the surface of your device is not altered or defaced. Do not decorate your assigned device/case or remove labels, stickers, or tags that are affixed by school personnel for identification purposes.

### I understand that:

- This device is for academic purposes.
- This device is assigned to me and is ALWAYS my responsibility.
- I will take proper care measures in using/handling/storing my device.
- I will use my device as instructed by teachers and/or my parents.
- I will come to school with my device fully charged and in its case.
- I will practice good internet safety behavior when online.

### Damage and Replacement of Devices

The device distributed to your child is a school-owned device, which serves as a learning tool to access different learning opportunities at school and home. It is a realistic expectation that the device will remain functional during four years of regular use. At times accidents will happen and the device may become damaged. In such cases when the damage was accidental, the student will be charged a fee of \$50.

*Repair or replacement costs for damage that is deemed to be intentional, along with items that are lost or stolen will be assessed as follows:*

- Power Cord - \$40
- Case - \$30
- Accidental Damage - \$50
- Repairs due to intentional damage – Actual cost to repair
- Lost Device – maximum of \$600 (depreciation of the device will be considered when applicable)

*Temporary devices will be available for student use upon arrangements for repair and payment.*
